TERMS AND CONDITIONS FOR SUPPLY OF ONCE USED GUNNIES AND 3PLY NEW SUTHLI

TS. Markfed proposed to purchase Once Used sound Empty gunny Bags of 50 Kgs (B-twill) to fill the 50 Kg and 3ply new suthli for packing **of all agriculture commodities to be** procured under MSP during this Kharif 2018-19 season in all the erstwhile districts.

General conditions:-

1. The tenderer must have PAN and GST number and furnish the copies along with the tender document.
2. Once the rates are finalized no escalation in the rates will be accepted during the contract period for any reason and no extra charges will be paid by the Federation.
3. All columns in tender form should be filled clearly and legibly. Tender form found incomplete in any respect is liable to be rejected.
4. Tender should be accompanied by affidavit sworn and signed on a Rs.20/- bond paper before a notary to the effect that the tenderer has no past or present criminal record with the police / vigilance and Enforcement Department and not blacklisted by any government organization/ agency for supplying of gunnies and suthili.
5. Tenderer should have experience in dealing with Govt. organization like State marketing federations and State civil supplies corporations in supplying jute gunnies.

Specific Conditions:

1. Gunnies should be once used and should hold and carry net weight of 50 Kgs grain of All agriculture commodities without any leakages.
2. Size of the bag with 94 x 57 cm, and the tare weight of gunny should be maximum 600 ± 20 gms only.
3. The requirement of once used gunnies will be as per the procurement of all agriculture commodities under MSP.
4. The rate should be quoted per gunny on FOL delivery at Markfed/PACS/DCMS agriculture commodities procurement centers including all other taxes in the state of Telangana.

5. The unloading charges of Gunny Bags at procurement center will be borne by the supplier.
6. The rate should be quoted per bag with 94 x 57 cm and 600 ± 20 gms specifications and the lowest rate should be considered by TS Markfed.
7. **The EMD of Rs.1,00,000/- (Rupees One lakh only) per Erst while district through e-payment.**
8. The Bidder is not eligible to quote for the all the districts by paying only one district EMD amount. **The bidder shall be entitled to quote for the EMD paid districts only.**
9. The gunnies should be re-placed at the cost of supplier at any stage if it is found inferior/broken or damage till the stocks reaches to the godown for storage purpose.
10. The District Managers of T S Markfed will pay 60% as advance of bill amount on receipt of stocks at Godown and on the submission of original bills raised with GST.
11. The balance 20 % will be paid at District Managers office on the basis of District Manager report on condition of once used Gunny at godown
12. The balance 20 % will be paid at District Managers office after the completion of agriculture commodities audit / after 60 days closure of agriculture commodities procurement by reconciling the bills submitted with the District Managers office and centers.
13. The gunnies should be preferably without having joints. The Supplier if supplied inferior once used Gunnies, the concerned District Managers will issue 1st notice. If the same is repeated by the supplier, second notice will be issued by the District Managers concerned.
14. If the supplier continue supplying the same quality after receipt of 2nd notice also , as per the report of District Managers, the supplier will be black listed and EMD/Security deposit will be forfeited and quality cuts will be initiated. In future supplier will not be entitled from supplier with T.S.MARKFED.
15. The EMD/SD will be refunded after the completion of procurement.
16. The leftover gunny bags should be taken back by the supplier at his cost from various centers as soon as the centers were closed, the proper acknowledgements shall be taken from concerned PACS/DCMS/ centre in-charges while supply and also while taking return of once used Gunnies. Further the T.S.MARKFED is not liable for any payment towards the return of once used gunnies from the purchase centers.
17. If the supplier fails to supply the gunnies within (3) days from the date of Indent, the Markfed is at liberty to procure from outside market or collect expenses incurred on account risk purchases made from the supplier.

18. The Markfed reserves the Right to accept of reject/cancel/any or all the tenderer without giving any reasons.
19. The un-successful bidders EMD will be refunded immediately.
20. Any dispute arising out of terms and contract or working there of shall be referred by either of the parties of arbitration before enforcement of T.S Markfed, Hyderabad/ any other officers appointed by Managing Director, T.S.Markfed.
21. The successful tenderer has to enter into the agreement on Rs. 100/- non-judicial stamp paper with the federation within three working days from the date of confirmation.
22. The Successful Tenderer has to deposit an amount of Rs.1,00,000/- (Rupees One Lakhs only) per erstwhile district towards Security Deposit by way of DD in favor of T.S. Markfed, Hyderabad in addition to the E.M.D already paid and it cannot be adjusted with any other previous years E.M.D or S.D amount with held with Markfed.
23. Final awarded Tenderer should submit two samples of once used gunny bags before the issue of work order.
24. The suthili should be new and 3 ply in good condition.
25. If it is found that the gunnies supplied are used more than once, the contract will be cancelled and EMD and SD will be forfeited and the tenderer will be blacklisted.
