1. Sealed Tenders are invited from the interested parties to purchase of Soyabean seed available in various PACS godowns procured during KMS 2016-17.
2. **DETAILS OF TENDER SCHEDULE :**
 - i. The Tender form and the tender schedules can be obtained in person from TS Markfed, Head Office, Hyderabad on any working day between **27.09.2018 to 29.09.2018 up to 1:00 p.m.**
 - ii. The tender shall be in the prescribed proforma only and shall be submitted in a sealed cover.
 - iii. Tenders will be received either by ordinary post/courier or by registered post or in person on all working days upto 1.00 p.m. on 29.09.2018. Markfed bears no responsibility for loss of tenders or delay in receiving the tenders sent by post/courier.
 - iv. All the tenders received will be opened at **3.00 p.m. on 29.09.2018** before the Managing Director, TS Markfed, Hyderabad in the presence of the tenderers or their authorized representatives present, if any.
 - v. The rate will be finalized after negotiations.

3. Rates should be quoted for purchase of Soya bean seed per Qtl. figures and words.
4. **Quality of Soyabean seed available**
Soya bean seed are procured in the KMS 2018-19 for distribution of Soybean seed to the Farmers and which was balance at the PACS godown.
5. **E.M.D.**
Every tender shall be accompanied by with an @ Rs.250/- per Qtl. of EMD by way of DD drawn on any nationalized bank in favour of **TS Markfed**, payable at Hyderabad. Tenders without EMD will summarily be rejected. It should also be noted that the EMD bears no interest.
6. The Tenderer who has submitted the tender shall be bound by the offer and by the terms and conditions.
7. The tenderer can quote the rate for single godown also. The offer will be valid for single godown only. The negotiations with tenderer will be allowed for the particular godown specified only.
8. The successful tenderers whose rates have been approved after negotiations shall deposit an additional amount of 10% cost of Soyabean seed allotted to them in favour of TS Markfed, Hyderabad by way of DD.

9. The SD furnished in the shape of DD bears no interest and the same will be returned along with EMD after successful completion of the liftings.
10. The cost of Soya bean seed shall be paid before lifting and EDM, SD will be adjusted in last day of lifting.
11. The tenderers whose rate is approved shall lift the stocks "as is where is basis" and the stocks shall be lifted on gross weight along with gunny bag weight.
12. The (15) days are free lifting period of confirmation of sale and additional (15) days will be given on payment of godown charges Rs.1/- per bag / per day.
13. After 30 days if the stocks are not lifted the Managing Director, TS Markfed, Hyderabad will be taking a decision for forfeit the EMD, SD.
14. The tenderer/s shall attach PAN No. and tin No. Xerox.
15. The rate quoted per Qtl. excludes all taxes if any.
